Program Level - Undergraduate certificate • Program Length - 43 weeks

This program is for Certified Ohio Emergency Medical Technicians who want to upgrade their certification to become a Paramedic. The program was designed in cooperation with area hospitals and life squads. It follows the standards set by the U.S. Department of Transportation's National Standard Training Program and is accredited by the Ohio Division of EMS, Public Safety Services.

STUDENTS

- Must be at least 18 years of age.
- Must be free of any current charges, incarceration and/or parole or probation for a felony offense.
- Must have approval from your EMT-A employer or squad chief.
- Are eligible to take the National Registry Exam after successfully completing this program.

Enrollment Requirements

Students wishing to enroll in the Paramedic program at Mid-East CTC-Adult Education **must complete the following enrollment procedures and have all information in the Admissions Office by June 28, 2019** in order to be considered for acceptance into this class:

Application: Students must complete a written Application for Admissions and return it to the Adult Education Office during your interview with the Admissions Coordinator. You may set an appointment with the Admissions Coordinator by calling 740-455-3111 or 1-800-832-7545.

General Assessment: A basic assessment is required to be completed by students entering this program. This will be scheduled through the Admissions Office during the interview process. At a later date you will be contacted by the Public Safety Coordinator, Mark Doerfler, at 740-455-3111 to schedule your personal interview.

Financial Aid: Arrangements to have the cost of tuition, books, and supplies paid in full, must be completed to the satisfaction of the Financial Aid Coordinator. Students may apply for Federal Financial Aid in the form of a Pell Grant by completing the Free Application for Federal Student Aid (FAFSA) at www.fafsa.ed.gov.

If a student is being funded by a local department, a written authorization must be in the Public Safety Coordinator's Office before June 28, 2019, or a Funding Determination Form must be submitted to the Financial Aid Office prior to acceptance.

Proof of Graduation: A copy of the student's high school transcript or high school equivalency (HSE) transcript must be submitted to the Admissions Office.

Background Check: You will need a BCI (Bureau of Criminal Identification & Investigation), and you will also need an FBI background check. If your background check is less than one year old from your program start date, it will be accepted as a current BCI/FBI. You may apply for these at the Sheriff's Office or Muskingum Valley Educational Service Center, 205 North 7th Street, Zanesville. **Ask to have the results sent to you, NOT TO Mid-East Career and Technology Centers.** You will need to send or bring a copy to the Admissions Office.

TB Test: Proof of a negative TB skin test (or x-ray for certain individuals, as defined by their healthcare provider, based on past medical and immunization history). This is also required yearly for the time the student attends Mid-East CTC Adult Education. The TB skin test can be obtained through the Rambo Memorial Health Center, located at 711 Main Street, in Zanesville.

EMT-B or EMT-I Card: A copy of the students EMT-B or EMT-I card must be submitted to the Admissions Office to be kept on file in the Public Safety Office.
