Children must be 4 Years of age by September 30th or 5 Years of age and NOT age eligible for Kindergarten

Class Time: 8:00am-3:00pm

Income verification must be a W-2 or the last two consecutive pay stubs

Age Verification: Birth Certificate

Completed Grant application: Provided by Director
